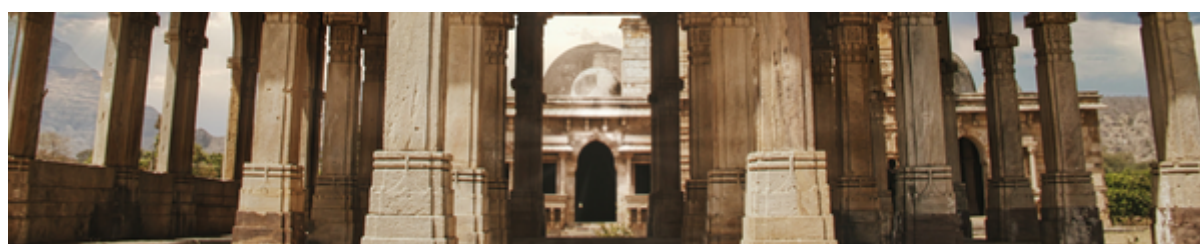
Match Funding

Aviva Community Fund - Cost of Living Boost

Grants are available through this match funding scheme to assist local not-for-profit organisations in the UK who are working to help local people in financial need. 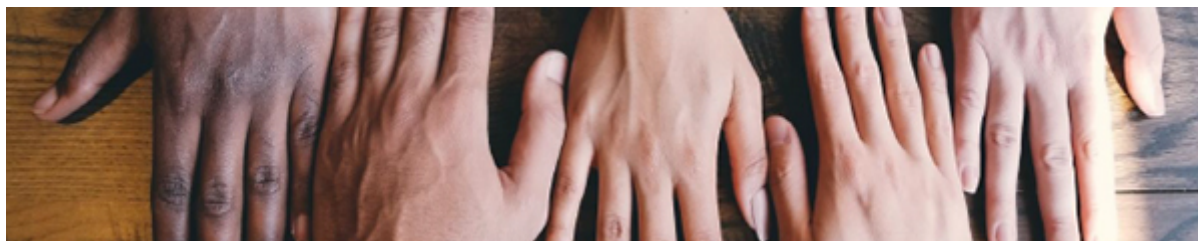
Cultural Protection Fund

Grants are available to not-for-profit organisations in the UK or overseas for projects focusing on the protection of cultural heritage under threat in one or more of the Fund's target countries. Deadline: 31 October 2022. Please [CLICK HERE](#) for more.

This programme is open to all cultural organisations with proven expertise in socially engaged artistic practice. Applications are now open for the 2023-2024 Cultural Bridge programme. This is an opportunity for arts organisations based in the UK who embody cultural democracy and wish to forge or develop bilateral partnerships to work together and share artistic practice. Independent Age – Cost of Living Grants Fund

The funding is intended as rapid response grants to local organisations across the UK, to help make sure that people aged over 65 do not have to choose between buying food to eat and heating their home. A total of £1 million is being made available with grants of £40,000. It is anticipated that 25 grants will be awarded. Projects should start from November 2022 and be completed by 31 December 2023. Jeans for Genes Grant Programme - Core Grants

Grants for core costs of up to £3,000 available to organisations serving the genetic condition community become stronger, more resilient, and sustainable improving their ability to meet need and provide appropriate support in the long term. Royal Society - Tomorrow's Climate Scientists

Schools can apply for grants of up to £3,000 to run investigative STEM projects in partnership with STEM professionals from academia or industry. Funding should be used predominantly to buy equipment. Please [**CLICK HERE**](#) for more.

Chelsea and Mr French Fund

Grants are available to local dog welfare and animal health charities working to support dog owners in the UK in times of personal struggle. Grants could be used for any kind of support for dogs which will allow owners to focus on getting themselves the help they require, eg providing emergency vet treatment or sourcing temporary foster care. Hampshire - New Forest Trust - Love the Forest Grants

The programme seeks to promote the conservation, protection, understanding and improvement of the New Forest. It is designed to help local organisations build their capacity to achieve these outcomes. Grants of between £50 and £5,000 are available for up to 100% of project costs. Patagonia International Environmental Grants

Grants are available to small grassroots activist environmental organisations in the UK and Ireland that are working to protect local habitats and frontline communities through bold, original actions. KFC Foundation

Looking to fund work that helps young people aged 11 to 25 years old. Registered charities, registered community interest companies, unincorporated clubs or associations or unregistered charities in the UK, with a turnover of less than £300,000 can apply. The Charity aims to help young people free themselves from poverty and disadvantage by heading into the job they want. In line with this aim, its Charities Programme has been established to award grants to registered charities in England and Wales for projects to support young people to move into employment or become employment ready. Oliver Ford Foundation

Funding of up to £10,000 is available for projects and initiatives that provide housing, education and training for individuals who have learning disabilities. National Lottery Community Fund - The People's Projects

Applicants should have a strong local presence and track record of delivering services in their area. Organisations should also consider whether they are comfortable running a public campaign which will require several months of commitment and bring significant publicity to the project. The funders are keen to support smaller organisations with an annual turnover of less than £500,000. 57 winners will receive grants of up to £70,000. Up to 38 runners-up will also receive grants of up to £10,000. Deadline: 12 noon on Friday 7 October 2022. Please [CLICK HERE](#) for more.

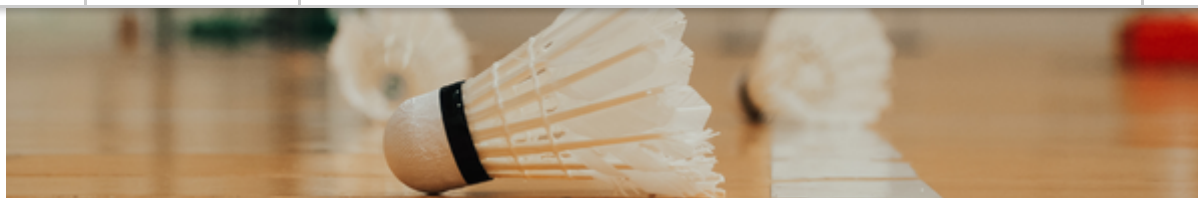
Customer and Communities Improvement Fund

Applications for this new round of funding can be made for projects which will be started and completed between 1 April 2023 and 31 March 2024. The closing date for bids is 23.59 on Friday 16th September 2022. Please [CLICK HERE](#) for more.

Asda Foundation - Cost of Living Grant

This is an Asda Foundation grant for local groups aimed at supporting increasing running costs that groups will face between September 2022 and February 2023. We know the rising cost of living is having a big impact on communities and this impact is going to increase. This grant is open to groups helping to address this issue. Cycling UK - Big Bike Revival Grants Programme

The programme supports people returning to cycling, starting as complete beginners, and other people who do not cycle regularly. The deadline for applications is the 10th of October 2022. England Boxing Together Fund

Grants are available to support the further growth and recovery of affiliated boxing clubs located in communities most in need in England. Grants of between £250 and £5,000 are available.
