Co-Op Warm Spaces Boost

This £1m match fund has been launched by Co-op to support eligible community groups who are supporting their communities through rising costs this winter, by bringing people together into warm spaces. Sovereign Thriving Communities Fund

Crowdfunder and Sovereign Housing have come together once again to help support projects benefiting Sovereign communities. The scheme will be open to any not-for-profit community or voluntary sector organisation located and delivering services in the borough of Basingstoke and Deane. Applications to the scheme will need to demonstrate clearly how the funding will help the borough's residents with the rising cost of living. The project must support children and young people who face barriers to make, learn or earn in music, and aims to make music activity more inclusive so everyone can access it. MSE - Raising the Next Generation

Projects applying for this grant should be groups supporting the younger generation (under 25) in helping them learn financial life skills and how to grow during the difficult financial climate. The Ann Rylands Small Donations programme makes grants to support charities' core costs with a maximum award of up to £5,000. It is designed to help smaller charities providing practical and emotional support to people with – or at high risk of – physical or mental ill health, people living with disability, and their families and carers. The Cobb Charity offers grants to smaller and "up and coming" charities working in the UK. The funding is for educational projects that encourage the awareness and application of environmental care and sustainability. Funding amounts are at the discretion of the Trustees. The Chestnut Fund

The Chestnut fund makes small grant available to community groups to encourage and enable them to carry out conservation activities. DCMS Youth Investment Fund

Phase 2 is intended to deliver up to 300 youth facilities, which can be new, extended, or repurposed. Applicants must be working with children and young people, where the majority are aged 11 to 19 years. Where young people have a special educational need, are leaving care, or are considered 'at risk' or vulnerable, funding may be granted up to the age of 25 years. Trusthouse Charitable Foundation - Small Grants

The foundation gives grants to small and medium sized local organisations in the UK which have a track record of success in working to address local issues in urban and rural communities of deprivation. It gives single year grants of between £2,000 and £10,000 for core costs, salaries, running and project costs in accordance with criteria that are regularly reviewed and decided by the Trustees. B & Q Foundation

The foundation will provide grants to local charities to support communities with projects to improve homes or a community space for those that need it most. They typically awards grants of up to £5,000, however they do occasionally award grants of larger values depending on the strength of the application and project. Funded from fishing licence sales, grants of up to £2,500 are available to benefit angling-based projects. The funding could be used to help purchase equipment, fishing tackle and resources to run fishing events and activities to give people the opportunity to get into fishing.
