Crowdfunder Cost of Living Crisis Emergency Fund

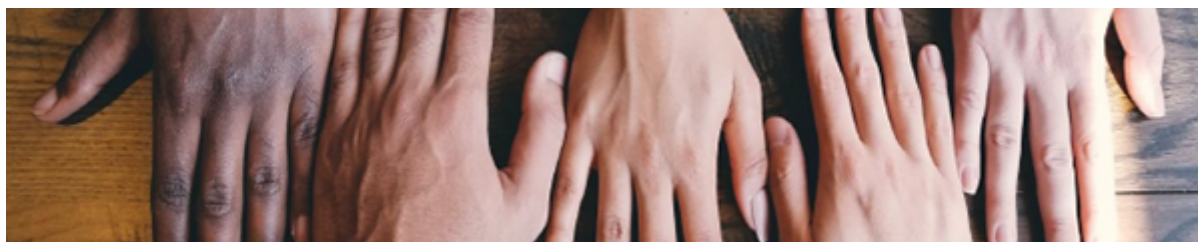
Association of Independent Museums (AIM) New Stories New Audiences Fund

Environmental Funders Network – Rapid Response Fund

The Rapid Response Fund aims to support groups who are trying to seize unexpected opportunities or react to unforeseen crises with a potentially significant environmental outcome. This means supporting organisations who need immediate help in response to situations that are not possible to predict or anticipate. The maximum grant available is £25,000. John Ellerman Foundation

The Foundation supports people, society and the natural world by focusing on the arts, environment and social action as these areas can make an important contribution to wellbeing. The minimum grant available is £10,000. There is no maximum limit. Most grants are for two or three years. The Foundation normally supports core funding but grants for projects are also available. Alec Dickson Trust

Grants are available to support volunteering projects in the UK, organised and run by young people (under 30 years). Specifically projects where it can be shown that through volunteering or community service they can enhance the lives of others, particularly those most marginalised by society. BBC Children in Need - Core Grants

Grants to cover core costs are available for not-for-profit organisations that are working with disadvantaged children and young people aged up to 18 years and living in the UK. There is no application deadline, you can apply at any time. Applicants to this programme can apply for grants for up to three years. They aim to give quicker decisions for grants of £15,000 or less per year. Please [CLICK HERE](#) to find out more.

Community Development



Royal Countryside Fund - Supporting Rural Communities Programme

The funding is for innovative projects that build resilience through community-led solutions, from groups and organisations who are working in villages, hamlets and small market towns. Grants of up to £25,000 over two years are available. Applications will be accepted from properly constituted, not-for-profit and community-led organisations with an income of less than £500,000 per year. Next deadline is 20th October 2023 (midday) Please [CLICK HERE](#) to find out more.

Southern Water Community Energy Grant

The funding is intended to support independently run community centres and spaces where activities such as local foodbanks, support groups and children's programmes operate, with energy costs to help relieve the pressure they face staying open during the winter months. Applications open on 3rd October and close on 31st October 2023 (midnight). A short application form will be available on the Southern Water website when the grant opens for applications. National Garden Scheme - Community Gardens Grants

The funding is for gardening projects carried out within local communities. There is no fixed amount, but awards are usually between £1,000 and £5,000. The funding is only available to projects run by amateur gardeners within community groups or Community Interest Companies (CICs). It should aim to bring a community together by creating a space people can share, by the acquisition and sharing of gardening knowledge and skills and by inspiring a love of gardening. The next application round (for funding in 2024) should open for applications on 2nd October 2023 and close on 13th November 2023. Please [CLICK HERE](#) to find out more.



The Primary Club - James Fund

The Primary Club provides financial support for a wide range of recreational and sporting facilities for the blind and visually impaired in the UK. Running costs and purchasing equipment can be funded. Applications must be submitted by the deadline of 31 October 2023. Please [CLICK HERE](#) to find out more.

Jordan Sinnott Foundation Trust

The Jordan Sinnott Foundation Trust provide grants to clubs, community groups and teams to support vulnerable and underprivileged children and young adults aged 5-21 years to access healthy recreation and sport so they can develop their capabilities and achieve their potential.
