The Arts for Impact campaign is aimed at supporting arts and culture charities working to achieve societal impact across the UK. Applications from charities interested in participating are open now until Friday, December 15th 2023. The campaign will see the public's generosity multiplied, as donations to the participating charities will be doubled by the Big Give's Arts for Impact match fund, which has been supported by generous 'champions', typically philanthropists, foundations or companies. Charities can apply for three tiers of match funding - £2,500, £5,000, or £10,000.

Neighbourhood Planning Grants and Support Programme

Grants and technical support are available for town and parish councils, neighbourhood forums and prospective neighbourhood forums to draw up a neighbourhood plan or neighbourhood development order in England. A basic grant of between £1,000 and £10,000 is available for groups writing a neighbourhood plan or neighbourhood development order. An additional grant of up to £8,000 is available for groups facing more complex issues. All grants must be spent before 31 March 2024. Please **CLICK HERE** to find out more.

Pub is the Hub encourages rural pub owners, licensees, and their local communities to work together to support, retain and locate local services, where possible, within the pub, whilst often improving the viability of the business itself. The provider may be able to assist some projects through its own Community Services Fund, which aims to support projects as a fund of last resort, where no local funding for services currently exists. A grant of up to £3,000 may be provided.
