Latest Funds

Council of Europe - Special call Ukraine

Applications can be submitted both for pilot activity grants and for international activity grants. Projects can be submitted at any time until the funds are exhausted. The special call is still open, and organisations can apply also for projects in 2024. Please [CLICK HERE](#) to find out more.

Youth Music Trailblazer Fund

The funding aims to support young people who want to change their lives through music but cannot because of who they are, where they are from or what they are going through. The grants (of £2,000 to £30,000) are for organisations who want to trial work for the first time, test a new way of working, or disrupt the status quo. Next deadline is 12th January 2024. Didymus Fund

The aim of this fund is to support smaller charities who are working to promote social inclusion through the arts and education, with an emphasis on planning for the future, capacity building and supporting specific projects. Grants of up to £10,000 per year for up to three years are available. Next deadlines for applications are: 31 December 2023 (noon) for February 2024 and 30 April 2024 (noon) for June 2024. The programme offers both an unrestricted grant and tailored support aimed at helping to strengthen charities and build the knowledge, skills and capabilities of staff and trustees. Hubbub – Nature Hubs Fund

Grants are available for registered organisations to deliver projects and activities that create or enhance green spaces within 5 kilometres of a Starbucks store. Grants of between £3,000 and £6,000 are available. The deadline for applications is 11 January 2024 (15:00). Please [CLICK HERE](#) to find out more.

Thomas Wall Trust - Grants for Registered Charities

Grants are available for UK registered charities for specific projects or core activities that equip disadvantaged people aged 18 and over with the necessary communication skills for employment. Army Benevolent Fund – Grants to Organisations

The funding is intended to support charities and organisations with projects and activities that directly benefit the Army community in six key areas: independent living, elderly care, education and employability, mental fitness, families and housing.
